What is legal research?


- How to find legal authorities: the process of
 - searching the relevant legal authorities governing your issues,
 - finding materials explaining or analyzing those legal authorities, and
 - sometimes, identifying distinguishing facts to support your advocates.



How is this class different?

ABA Requirement (1)

- ABA Model Rule of Professional Responsibility 3.3(a): a lawyer should not knowingly
 - make a false statement of material fact or law to a tribunal, or
 - fail to disclosure legal authority ... to be directly to be adverse to the position of the client ...



ABA Requirements (2)

 ABA Standards and Rules of Procedure for Approval of Law Schools, 302(a)(2): "A law school shall require that each student receive substantial instruction in: ... legal analysis and reasoning, legal research, problem solving, and oral communication;"



Why Do Legal Research?

Globalization: integrating nations and peoples – politically, economically, culturally, and legally – into a larger community.



2015 Legal Research Survey Conducted by Lexis


- New attorneys spend between 40-60% of their time conducting legal research and an average of 12 hours per week on paid services like Lexis Advance
- 88% of hiring partners think proficiency using "paid for" research services is highly important for practitioners
- 86% of hiring partners and supervising attorneys deem legal research skills as highly important in young associates
- Over 60% of attorneys would be pleased to see a Research Certification, Drafting certification or similar certification designation on a candidate's resume.

Evaluate Research Outcome

- Beginning: did not consult secondary sources covering the relevant area of law
- <u>Developing</u>: selected one or more sources that cover the topic, but either too generally or too specifically to serve as an adequate starting points; source(s) was unlikely to contain citations to the specific jurisdiction.
- <u>Proficient:</u> selected one or more sources providing an accessible overview of the relevant area of law; source(s) was either jurisdictionally or topically specific.
- 4. <u>Highly Proficient:</u> Selected multiple sources providing an accessible overview of the relevant area of law along with a more in-depth treatment of specific issues; at least one of the sources was jurisdictionally specific.

Primary Sources (Types) of Law 原始(一次) 法律资源(渊源)

- Legislative (Congress) 立法(议会)
 - Statutes enacted by elected bodies 成文法
- Executive (President and Agencies)行政
 - Executive Orders and Directives from President) 行政命令
 - Rules and Regulations 法规
- Judicial (Judges and Courts) 司法
 - Opinions issued by Courts 判例



Primary Sources

- 1. Statutes: bills, acts, statute compilation, codes,
- 2. Administrative Regulations: regulations, rules, executive orders, regulation/rule compilations, administrative code,
- Judicial interpretations, cases, court rules, sentencing guidelines, etc.



Secondary Sources二次资源: about law 解释法律

- Study Aids: hornbooks, nutshells, etc. 学习辅导
- Legal Encyclopedias 法律百科全书

- ■非强制性但有说服力的法律文献




法律检索概述




